



Location Centro City will transform an existing shopping 3825 NW 7th St center into a community-centered mixed-Miami, FI 33126 use destination with the construction of 1,188 apartment units and public open spaces, tied to flagship retail stores including Fresco y Más, Ross, Walgreens and Target. This development will be Leasable Retail Area located on a 39-acre site located at the northwest 320,000 SF corner of NW 7th Street and NW 37th Avenue in Miami, FL, across the street from the historic Magic **Rental Units** City Casino, a Miami gaming and entertainment 1,188 units institution. There is a significant lack of supply and a high demand for new construction multifamily in this urban infill submarket, and Centro City will Acreage serve to fill that void. **39 Acres**


